It also ensures the employer keeps its place in the market. Non-competes agreements are tailored to be highly favorable to employers and highly unfavorable to employees. Signing a non-compete agreements can adversely impact an individual's livelihood since it can preempt the individual from being able to earn revenue by severely restricting their ability to work.
